- **Murder** is the willful killing of one person by another person. Traffic fatalities, suicides, and accidental deaths are not murders.
- **Robbery** is a theft that takes place when the victim is directly confronted by the perpetrator and involves the use or threat of force.
- **Aggravated assault** is an unlawful attack against someone, usually involving a weapon (gun, knife, club, poison, car (possibly), etc.), where the perpetrator intends to inflict serious bodily harm.
- **Burglary** is an unlawful entry into a structure with the intent to commit a felony or theft. Examples including breaking into another’s hotel room to steal items or breaking into another’s house to commit a statutory rape. Breaking into an automobile, stealing from a vending machine, and shoplifting from a commercial establishment are not considered burglaries.
- **Motor vehicle theft** is the theft or attempted theft of a motor vehicle, not stealing something from within a motor vehicle.
- **Manslaughter** is killing someone through gross negligence (failing to act like a reasonable and prudent person). The death of someone due to his/her own negligence, accidental death not resulting from gross negligence, and traffic fatalities are not considered manslaughter.
- **Arson** is the willful or malicious burning or attempt to burn a house, building, motor vehicle or aircraft, personal property of another, etc. Arson includes the willful or malicious burning of one’s own property but does not include accidental fires or fires of suspicious or unknown origin.
- **Rape*** is the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim, including instances where the victim is incapable of giving consent (incapacitated by drugs or alcohol, asleep or unconscious, certain mental or physical disabilities, etc.).
- **Fondling*** is the touching of the private body parts of another person without consent of the victim, including instances where the victim is incapable of giving consent (as discussed above).
- **Incest*** is sexual intercourse between related persons, including parents, children, stepchildren or adopted children, half-siblings, grandparents, grandchildren, uncles, aunts, nephews, and nieces.
- **Statutory rape*** is sexual intercourse with a person fifteen years old or younger (if the alleged perpetrator is at least a certain number of years older).
- **Domestic violence*** is a felony or misdemeanor crime of violence committed by a current or former spouse or intimate partner or someone similarly situated to a spouse or intimate partner. Domestic violence includes violence against children, parents, or the other parent of a person’s child but does not include violence between platonic roommates.
- **Dating violence*** is violence or threat of violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. Dating violence does not include acts covered under the definition of domestic violence.
- **Stalking*** is engaging in two or more acts directed at a specific person that would cause a reasonable person to (a) fear for his/her safety or the safety of others; or (b) suffer substantial emotional distress. Stalking can take place electronically (text message, email, Facebook, etc.).
